## REGULATIONS IN FORCE

BY SIGNING AND SUBMITTING THE SUBSCRIPTION FORMS (EXHIBITION SPACE, FURNITURE, BUSINESS MEETINGS, ETC.) THE EXHIBITOR ACKNOWLEDGES THE BINDING NATURE OF THE EXHIBITION REGULATIONS GOVERNING THE ORGANISATION OF FIAC. HOWEVER, THE ORGANISER RESERVES THE RIGHT TO PRESCRIBE AND ENFORCE, IF CIRCUMSTANCES SO REQUIRE, MORE EXTENSIVE PROVISIONS AND GUIDELINES IN THE GENERAL INTEREST.

## PAYMENT AND INSTALLMENT TERMS

TO GUARANTEE THE ALLOCATION OF HIS STAND OR BARE SPACE AND THE RELATED SERVICES ORDERED, THE EXHIBITOR IS REQUIRED TO PAY THE AMOUNT OF HIS INVOICE OR TO MAKE AN ADVANCE PAYMENT OF AN AMOUNT OF HIS CHOICE, AT LEAST GREATER THAN OR EQUAL TO 30% OF THE INVOICE BEFORE 15 MARCH 2023 AND TO PROPOSE A PAYMENT SCHEDULE RUNNING UNTIL THE OPENING OF THE FAIR, AT THE LATEST. THE SERVICES ORDERED ON THE EXHIBITION SPACE FORM, DATED, SIGNED AND SEALED, ARE ONLY PAYABLE TO THE ORGANISER ON FULL PAYMENT OF THE CORRESPONDING INVOICE SENT.

## CONFIRMATION OF THE EXHIBITION CONTRACT

THE SUBSCRIPTION IS CONFIRMED AND THE ALLOCATION OF THE STAND IS DEFINITIVE AFTER FULL PAYMENT OF THE INVOICE DUE. THIS LIFTS THE ADMISSION RESERVE AND ENABLES THE ENTRY VOUCHER TO BE OBTAINED WHEN THE STANDS ARE SET UP.

## PAYMENT TERMS

THEY ARE CLEARLY MARKED AT THE BOTTOM OF EACH INVOICE ISSUED BY THE ORGANIZER

## TERMINATION OF THE EXHIBITION CONTRACT

THE EXHIBITOR WHO WISHES TO TERMINATE THE CONFIRMED SUBSCRIPTION WITH THE ORGANISER IS OBLIGED TO MAKE THIS KNOWN EXCLUSIVELY BY POST, POSTAGE PAID, BY 15 MARCH 2023 AT THE LATEST. THIS UNILATERAL INITIATIVE TO TERMINATE DOES NOT RELEASE THE EXHIBITOR FROM THE SUBSCRIPTIONS MADE. IF THE CANCELLATION IS MADE BEFORE 15 MARCH 2023, A DEDUCTION OF 20% ON THE TOTAL AMOUNT INVOICED WILL REMAIN DUE. 15 MARCH 2023, THE EXHIBITOR SHALL REMAIN LIABLE FOR ALL SERVICES SUBSCRIBED AND INVOICED.

## DAMAGE TO PROPERTY AND INSURANCE

THE ORGANISERS ARE COVERED FOR THE ORGANISER'S CIVIL LIABILITY AND DAMAGE TO PROPERTY RISKS. EXHIBITORS WHO HAVE NOT INSURED THEIR GOODS TO BE EXHIBITED AT FIAC AND COVERED THEIR CIVIL LIABILITY BY INSURANCE ARE STRONGLY ENCOURAGED TO DO SO BY TAKING OUT AD HOC INSURANCE FOR FIAC. THE ORGANISER HAS NEGOTIATED FAVOURABLE CONDITIONS WITH A PARTNER INSURER (AVAILABLE ON OUR WEBSITE OR AT THE FIAC SECRETARIAT). UNDER NO CIRCUMSTANCES CAN THE ORGANISERS BE HELD RESPONSIBLE FOR THEFT OR DAMAGE TO AN EXHIBITOR'S STAND, DAY OR NIGHT.

## APPLICABLE RIGHT

ANY EXOGENOUS CIRCUMSTANCE, AND IN GENERAL, ANY CASE OF FORCE MAJEURE THAT PREVENTS THE EVENT FROM TAKING PLACE OR RESTRICTS ITS IMPORTANCE, CANNOT BE INVOKED AGAINST THE ORGANISER, AND THE EXHIBITOR MAY NOT CLAIM ANY COMPENSATION. FOR ANY DIFFICULTY THAT MAY ARISE FROM THE INTERPRETATION AND EXECUTION OF THESE EXHIBITION REGULATIONS, THE FRENCH VERSION SHALL PREVAIL. THE PARTIES AGREE TO SETTLE ANY DISPUTE THROUGH CONSULTATION. AND IF NECESSARY, THE DISPUTE WILL BE SETTLED BY THE ARBITRATION OF THREE PERSONALITIES DESIGNATED BY THE PARTIES. THE ORGANISER WILL ACT WITH THE AGREEMENT AND SUPPORT OF ITS GOVERNMENTAL MANDATOR.

## ADDITIONAL CONDITIONS

AFTER THE ALLOCATION OF HIS STAND OR BARE SPACE, THE EXHIBITOR RECEIVES ADDITIONAL INFORMATION TO PREPARE HIS PARTICIPATION IN THE FAIR THROUGH INFORMATION NOTES OR PUBLIC INFORMATION MEETINGS. SPECIAL TECHNICAL SERVICES OR STAND DESIGN WILL ONLY BE CARRIED OUT ON THE BASIS OF ORDERS ACTUALLY PLACED USING THE ORDER FORMS PROVIDED FOR THIS PURPOSE AND AVAILABLE ON OUR WEBSITE OR FROM THE ORGANISER'S SECRETARIAT.

## STATEMENT OF COMMITMENT AND CONFIRMATION

BY SIGNING AND STAMPING, THE EXHIBITOR ACKNOWLEDGES HAVING RECEIVED, READ AND ACCEPTED THE TERMS OF THE EXHIBITION REGULATIONS.
